He is focused on protecting and growing the state's assets while ensuring all Rhode Islanders have the financial foundation to thrive. Since taking office, he has worked to sustainably grow and diversify the state's \$13 billion pension fund, strengthen Rhode Island's bond rating, and expand access to economic opportunity.

Under his leadership, Treasury has launched several initiatives to support Rhode Islanders, including RISavers, which expands retirement access to the 40% of private-sector workers without employer-sponsored options, and the RI AnchorHome pilot program, which offers low-interest home loans. Treasury has also expanded efforts to return unclaimed property, reuniting residents with millions of dollars. In addition, Treasurer Diossa has strengthened financial education statewide, convened municipal leaders on public finance, and launched a medical debt relief initiative that eliminated \$12 million in debt.
